a. Public Works Maintainer/Operator

Jared Hoekstra has accepted the position.

b. Seasonal Park Maintainer

Administrator Donner said two seasonal maintainers will be coming back this summer. We are still looking to fill one more position. Director Osterbrink conducted an interview today. In addition, our Seasonal Utility Maintainer will be coming back for his third summer.

8. Discussion on adjusting the Classification and Compensation Matrix

Donner talked briefly about the Village's employee compensation matrix. An in-house compensation study was performed in 2018. There was short discussion on when and how the pay matric should be adjusted. Hackbarth said it is a good idea to look at pay rates annually to keep up with the market and maintain competitiveness. President Maloney asked about going beyond the matrix parameters. Donner said we want it to land within the parameters. We need to be competitive, but we also need to maintain the equality of the employees. Hackbarth said there is a Central Wisconsin HR Society that does a salary survey every year and she will get the information to Administrator Donner. Weinkauf stated we used to be members of IPMA-HR and they used to provide salary surveys. This is geared toward the public sector but is an international organization. Hackbarth said its helpful if they break down the data per region, not nationwide.
